As part of an established team, your primary focus will be the effective case management for children and young people aged 0-18 years in Kinship placements, supporting them with their day-to-day challenges, to build positive relationships and to engage in activities to enhance their resilience and self-esteem.

Your purpose is to improve outcomes and make a difference to the lives of children and young people through your actions and behaviours as you deliver services and support to achieve the program's goals and objectives.

There will be opportunities to grow your skills and experience, and you will be provided with support, coaching and supervision, and professional development to set you up for success.

As **Case Manager – Kinship Care** your duties will include:

- Case management for carers and children
- Assessment and placement plans
- Supporting carers around the complexities in relation to family access
- Supporting children in care
- Promoting positive relationships in family systems
- Ensuring relevant paperwork and administrative work is up to standard for reporting

Qualifications

As a Case Manager – Kinship Care, we are looking for someone who can provide high-quality services that will help bring about significant improvements in the life experience of children, young people and families/caregivers.



To succeed in this role, you will also have:

- Experience working with children and young people, birth families, kinship and or foster families in an OoHC funded service.
- An understanding of the theoretical frameworks that underpin Anchor's approach to out of home care, child development, attachment, grief and loss and trauma.
- Demonstrated understanding of the key components of case management.
- The commitment and capacity to negotiate and liaise with carers, staff, DHHS, and other agencies and services.
- An ability to contribute to an evidence base that will inform further development of services for children and young people with complex and very challenging needs.
- A willingness to engage in a range of practice frameworks, including Advantaged Thinking.
- An understanding of the complexity of the service system and the issues involved in providing services to statutory clients.
- A minimum four-year degree qualification in Social Work, Psychology, Community Services, or a related discipline, recognised in Australia.
